General Contracting (residential and commercial construction, electrical, plumbing, HVAC)	15 mils
Professional Services (medical, legal, accounting/bookkeeping, engineering, consulting services, therapeutic)	12.5 mils
Retail (convenience stores, grocery, food and beverage establishments, restaurants, coffee shops, clothing stores, craft/gift shops)	10.0 mils
Tourist Accommodations	5.0 mils (Minimum \$500.00)
Seasonal Business Operations (financial documentation must be provided to support classification as a seasonal business operating 6 months of the year or less)	7.0 mils

An 8% discount will be applied to residential property taxes paid in full by March 31, 2025. All taxes are due and payable by June 30, 2025. Simple interest on arrears will be applied at 1.5% per month or 18% per annum. The Town of Witless Bay accepts cash, cheque, debit, credit card and e-transfer.
