b. BBBAA – Request to reconsider funding amount

Discussion: Councillor Alex Troake

Council received a letter from the BBBAA in the Fall requesting \$50,000 in funding for 2022. The request was seriously considered as part of the overall budgetary process. The 2022 budget includes \$37,000 to support the BBBAA, respecting a MOU signed by the previous Council. While this Council fully supports recreation, we have limited financial resources to address years of neglect in the community, and support growth and community development. To approve additional funding for the BBBAA is irresponsible as it would mean taking away from other areas, such as roadwork, community services or support for other community groups. However, since the MOU expires this year, we plan to work with the BBBAA throughout the year to come up with a suitable funding model moving forward which provides accountability, predictability and represents good value to the residents of Witless Bay.

Discussion: Councillor Alex Troake

First of all, I'd like to thank Mayor Croft and Deputy Mayor Yard for assisting me in the recruitment of a new Town Manager. By handling this internally, we were able to have greater control and visibility over the process, and save taxpayers between \$4,000-\$5,000 for just this position. I'd also like to thank all the candidates who came forward to offer their energy and experience to Witless Bay.

We are excited to welcome Shawn Kavanagh to our team. Shawn grew up in Calvert and has deep roots in Witless Bay, having spent time at his grandparent's home on Fisherman's Road and living there in recent years.

In 2011, Shawn graduated from Memorial University with a Bachelor of Arts (Honours). He went on to graduate with a Master of Arts from Queen's University in Political Studies in 2012, and in 2016 he graduated Juris Doctor from the University of New Brunswick. Shawn was called to the bar in 2017, and brings significant experience in Municipal Law as well as labour relations.

Shawn has significant experience in studying and examining public policy under some of Canada's greatest scholars in the area, experience which will prove invaluable when tasked with helping Council develop public policy.

As a volunteer, Shawn is currently serving as the Chairman of the Calvert Local Service District, a member of the Southern Shore Joint Council, as well as a member of the Board of Directors for the Community Business Development Corporation Celtic.

- a. Request for funding towards repairs to the Bay Bulls Regional Lifestyle Centre

Discussion: Councillor Alex Troake

At the request of the Town Council in Bay Bulls, the Witless Bay Council attended a meeting in Bay Bulls on November 29, 2021 to discuss fire services in the region, specially fire protection fees and the new Fire Hall project. At the end of the meeting, Bay Bulls brought up the need for repairs to the roof at the Bay Bulls Regional Lifestyle Centre, and were looking for Witless Bay to contribute funding since they considered it a regional facility. Since there had been no prior discussion of this, a presentation or any documentation presented, Witless Bay requested a formal letter/proposal be sent to the Town Office for consideration. Unfortunately, no further correspondence was received until January 4, 2022, after the Witless Bay 2022 budget was finalised and approved. Therefore, the Town of Witless Bay is not in a position to contribute funding for the Bay Bulls Regional Lifestyle Centre in 2022. However, given the importance of recreation, regional cooperation, and the fact that the BBBAA MOU expires in 2022, we should look at how we fund/operate all recreation assets in the region. We do have to be mindful of the recreation assets here in Witless Bay, to ensure they are properly funded, and how they would fit into any agreement moving forward.

a. Backlot Development (Discretionary Use) - 63-65 Dunn's Lane

The subject property appears capable of meeting the lot area, lot frontage and building setback requirements of the Residential Zone for a Backlot Development. However, as has been noted, the information submitted by the applicant is not adequate to determine conclusively that all requirements of the Development Regulations relevant to a Backlot Development at this location can be satisfied.

It is recommended that Council defer consideration of this application to enable the Town Planner to request that the applicant provide the Town with the following information necessary to establish conformity with municipal requirements:

- 1. A stamped and signed legal survey of the proposed building lot;
- 2. A sufficiently detailed site plan (or Location Certificate) drawn to a satisfactory scale showing the exact setbacks of the proposed dwelling from all property lines;
- 3. Submission of a satisfactory lot grading and drainage plan that meets the approval of the Town Engineer;
- 4. A report of a geo-physical assessment of the subject property conducted by a Professional Engineer or other person qualified to make a determination, to ensure development can take place without endangerment to health or safety;

Discussion: Councillor Alex Troake

I acknowledge that the BBBAA requested an additional \$13,000 in funding, and was looking to receive the entire \$50,000 in one payment. However, the signed MOU between the Town and the BBBAA sets the amount of annual funding at \$37,000 to be paid in 2 instalments. The Town was able to provide a one-time increase in funding for 2021 based on COVID funding received from the government. In 2022, any increase over-and-above \$37,000 would have to be funded by the taxpayers of Witless Bay, and that would mean cuts to other areas of the budget. While the Town fully supports recreation and youth, we also have to consider our own cash flow and the taxpayers of Witless Bay. Since the After School Program runs a profit each month, and the BBBAA ended 2021 with just over \$150,000 in assets, including almost \$140,000 in cash, I trust their Board can work with the \$74,000-\$87,000 it will receive from Bay Bulls and Witless Bay in 2022 to cover their financial obligations and continue their programming uninterrupted.

g. Eastern Waste Management – Motion to renew garbage collection contract

The Eastern Regional Service Board advised the Town of a fee increase of \$20/household (from \$180 to \$200) in 2022. While this represents the first increase since 2011, being a new Council committed to controlling costs, we asked Town staff to look into alternative service providers. Based on their research, the bet option is to remain with Eastern Regional Service Board.

Community Enhancement Committee (CEC)

Oral Report to Town Council

Councillor Nancy Burke, as citizen

February 8, 2022

This oral report is an information item for Council and the residents of Witless Bay.

- A group of residents of Witless Bay met on October 5, 2021, to discuss establishing a Community Enhancement Committee to contribute to the liveability of Witless Bay.
- The citizens wanted to build on citizen-led initiatives undertaken in 2021, such as clean-up on Gully Road, efforts at Alderwood Estates to engage residents that have generated positive media for the community, and the Historic Places Walk hosted by the Heritage Committee.
- These residents are interested in undertaking citizen-led projects to enhance services within the community.
- Youth come to Witless Bay from the region. The citizens want to work with the Town Council, community groups, and partners in the region, i.e., Bay Bulls to Bauline.
- Among the ideas generated for action were enhancing/developing:
 - youth programming as there are limited programs for youth 13-18 years, e.g., drop-in centre where youth could engage in youth-led music and arts programs
 - public spaces, e.g., community garden, access to the beach via folding steps and boardwalk, fire pits on the beach,
 - community events, e.g., BBQ and bonfire on the beach,

- walking trails that are accessible for people with all levels of ability,
- animal control measures so residents feel safe walking around the community,
- seniors' programs, i.e., affordable housing, transportation.
- The CEC intended to have a public meeting to inform the residents of Witless Bay and invite participation from interested citizens.
- Covid-19 restrictions were tightened, and a public meeting could not be held.
- However, despite the restrictions, a small group have been working on youth programming by collecting information about programs that are available, and contacting school principals, representatives of organizations, the Town of Bay Bulls, and local service districts to gauge their interest in working to enhance youth programming in the area. To date, there has been support for the work of the youth sub-committee, and work is ongoing.
- Further, the CEC has made representation to the Town Council of Witless Bay to:
 - During its budget deliberations, to set aside funding for maintenance of existing trails and replace missing story boards, and
 - Protect the railbed and trestle for use as a public trail for use by residents for recreational activities, such as, walking, cross-country skiing, ATV use.
- As soon as the Covid-19 restrictions allow, a public meeting will be called to discuss the activities of the CEC.
